

## **New Alberta Covid-19 Restrictions**

The City of Calgary and WinSport (COP) will be participating in the [Restrictions Exemption Program](#). As permit holders in these facilities, Calalta will also be participating in the program, and the following restrictions will be in effect:

### **Users 12 years of age and older**

- Effective September 20th, users 12 years and older are required to show proof of vaccination.
- Single dose accepted between September 20 and October 25 if received 2 weeks before entering the facility **or** proof of a privately paid negative PRC or rapid test within 72 hours at entry.
- Proof of vaccination can be the:
  - paper record received at immunization appointments.
  - records shown from the MyHealth Records app or website; or
  - printable card from MyHealth Records app along with photo ID for ages 16 and older
- **Bring your ID and documents with you every day.**

### **Users under 12**

- Come to the rink as ready as possible. One support person will be permitted to quickly assist the child before moving to the spectator area.
- All children 0-11 years of age **will not be required** to show proof of vaccination, or a negative COVID-19 test.

### **Additional Restrictions**

- Face coverings must be worn by all users in the following areas:
  - All entrances, hallways, lobbies, and public seating areas.
  - All washrooms and lockers rooms, including when transitioning.
- Face coverings are not required:
  - When participating in a physical on court activity
  - For children under 2 years of age
- Health screening with the check in person or coach each time you enter the facility
- Always maintain a distance of 2 meters when not participating in an activity

### **Coaches, Rink Chair (check in volunteers), and Instructors**

We need our front-line people to immediately provide the following as an extra layer of compliance.

- Calalta is the permit holder in these facilities, and it is our responsibility to ensure all restrictions are followed.

### **If fully vaccinated**

- Scan or take a picture and email a copy of your records to [info@calalta.net](mailto:info@calalta.net) .
- Bring your proof of vaccination and ID with you everyday.

### **If partially vaccinated**

- Scan or take a picture and email a copy of your records to [info@calalta.net](mailto:info@calalta.net) .
- First dose and then second dose when received.
- Must be fully vaccinated by October 25.
- Bring your proof of vaccination and ID with you every day.
- Proof of negative COVID test if first dose was administered less than two weeks ago.

### **If not vaccinated**

- Proof of a privately paid negative PCR or rapid test within 72 hours of entering the facility (tests from AHS or Alberta Precision Laboratories not allowed).
- Send in proof of a negative PCR or rapid test every 72 hours.
- Those who cannot be vaccinated for medical reasons must provide a negative test to ensure the safety of all participants and staff.
